1. This Invitation for Bids follows the Anticipated Procurement Notice for this Project that appeared in the CFSI website (www.cfsi.ph). and Invitation for Bids published last 13 August 2016 in the Mindanao Cross and The New Ranao Star, Volume VI, No. 5 (08-14 August 2016)..
2. Community and Family Services International (CFSI) has been designated as Trust Fund Recipient of the Mindanao Trust Fund – Reconstruction and Development Program (MTF-RDP), a World Bank administered multi-donor fund, established to consolidate international development assistance for the socio-economic recovery of conflict-affected communities in Mindanao. CFSI intends to apply part of the proceeds of this Grant to payments under the Contract for Camps Project.
3. After the failure to secure qualified contractors and responsive bids in the Original Bidding process for nine (9) Bid Packages, CFSI now is conducting a second bidding and invites sealed bids from eligible and qualified bidders for various Works to be implemented in areas of Mindanao, listed in the table below. The delivery/ construction period is in the range of forty (40) to ninety (90) days.

4. Bidding will be conducted through the Local Competitive Bidding (LCB) and is open to all bidders from the project sites or their vicinity and other eligible bidders as defined in the Bidding Documents.
5. Interested eligible bidders may obtain further information from Ms. Emma D. Naga, and inspect the Bidding Documents at the address given below.
6. Qualifications requirements include: legal registration as a business entity, experience in the same or similar project, and financial capacity to undertake the Works. Specific requirements are contained/specified in the Bidding Documents.
7. A complete set of Bidding Documents in *English language* may be purchased by interested bidders from 05 September 2016 to 09 September 2016 on the submission of a written application to the address below and upon remittance of a non refundable fund contribution in the amount specified in the table above in Philippine currency. This contribution is to cover documentation expenses related to the bidding. The method of remittance will be *in cash or through bank manager's/bank cashier's check*. The Bidding Documents will be available for pick up at the same address by the prospective bidder or its authorized representative.
8. Bids must be delivered to the address below at or before *10:00am, 12 September 2016*. Electronic bidding shall not be permitted. Late bids will be rejected. Bids will be opened physically in the presence of the bidders' representatives who choose to attend in person at the address below at *10:00am, 12 September 2016*. A Pre-Bid Conference will be conducted at *10:00am, 08 September 2016* at the address specified below.
9. All bids shall be accompanied by a *bid security* in the form of a bank guarantee in the amount equal to 2.5% of the estimated project cost or, alternately, in the form of *cash or bank manager's/cashier's check* in the amount of equal to 2.0% of estimated project cost. The exact amount of the bid security is specified in the Bidding Document for each package/lot.
