# **Request for Bids**

(Local Competitive Bidding No. 02)

# 1. Procuring Entity

Community and Family Services International (CFSI) is the Trust Fund Recipient and, as such, the primary procuring entity for the World Bank-administered Mindanao Trust Fund – Reconstruction and Development Project Phase II (MTF-RDP/2). This initiative, known as MTF-RDP/2, is in support of the implementation of the Comprehensive Agreement on the Bangsamoro (CAB). They include funds for community-managed Socio-Economic Infrastructure (SEI).

# 2. Implementing Partners

CFSI, working in close collaboration with the Bangsamoro Development Agency (BDA) and the Joint Task Force on Camps Transformation (JTFCT), now requests sealed bids from eligible and qualified bidders for various Works to be implemented in areas of Maguindanao, North Cotabato and Lanao del Sur in the table below. The delivery/construction period is in the range of ninety-five (95) to one hundred (100) Calendar Days.

# 3. Procurement Method

Bidding will be conducted through the Local Competitive Bidding (LCB) method and is open to all interested bidders from the project areas or their vicinity, and other eligible bidders as defined in the Bidding Documents. Interested eligible bidders can obtain further information from the Chairperson of the Joint Procurement and Evaluation Committee (JPEC) and inspect the Bidding Documents at the addresses given at the bottom of this announcement.

#### 4. Bidders General Qualifications

Qualifications requirements include: legal registration as a business entity, accreditation with the Philippine Contractors Accreditation Board (PCAB), experience in the same or similar project, and clear financial capacity to undertake the Works. Specific requirements are contained/specified in the Bidding Documents.

Contractors with Poor or Very Poor performance in the previous phases of MTF-RDP, including their Authorized Representatives, shall not be allowed to submit bids while the number of Sub-Projects that can be contracted by those with less than satisfactory performance may be limited to one or two only.

#### 5. Issuance Bid Documents

A complete set of Bidding Documents in English may be purchased by interested bidders from **12 March 2020 to 24 March 2020 for CRA-SEI-03 & CRA-SEI-04 and 12 March 2020 to 27 March 2020 for CBI-SEI-03** upon submission of a written intent/application to either of the addresses below and upon remittance of a non-refundable fund contribution in the amount of Four Thousand (P4,000.00) Pesos in Philippine currency, in the form of cash. This contribution is to cover documentation expenses related to the bidding. The Bid Documents can be purchased by the prospective bidder or its authorized representative at the CFSI Offices in Cotabato City and Iligan City with their address provided below.

#### 6. Pre-Bid Conferences

Pre-Bid Conferences for CRA-SEI-03 and CRA-SEI-04 will be conducted at **9:00 AM, 18 March 2020** at CFSI Operations Center, 21 Rosales Street, Cotabato City and CBI-SEI-03 will be on **9:00AM on 23 March 2020** at CFSI Sub-Office Iligan, No. 35 Picardal Street, Mahayahay, Iligan City.

#### 7. Deadline of Bids Submission

Bids submission of CRA-SEI-03 and CRA-SEI-04 will be on or before **11:00 AM of 24 March 2020**, at CFSI Operations Center, 21 Rosales Street, Cotabato City. And Bid submission of CBI-SEI-03 will be on or before **11 AM of March 31, 2020**, at Sub-Office Iligan City, No. 35 Picardal Street, Mahayahay, Iligan City.

Late bids will be rejected. Bidders are encouraged to submit their bids as soon as practicable to avoid disqualification.

#### 8. Site Inspection

Site Inspection for sub-projects CRA-SEI-03 and CRA-SEI-04 will be conducted on 20 March 2020 while site inspection for CBI-SEI-03 will be done on 24 March 2020.

#### 9. Bids Opening

Bids for CRA-SEI-03 and CRA-SEI-04 shall be opened physically in the presence of the bidders or their authorized representatives who choose to attend at 1:00 PM on 24 March 2020 at CFSI Operations Center, 21 Rosales Street., Cotabato City. And Bids for CBI-SEI-03 shall be opened physically in the presence of the bidders or their authorized representatives who choose to attend at 1:00 PM on 31 March 2020 at CFSI Sub-Office Iligan, No. 35 Picardal Street, Mahayahay, Iligan City.

#### 10. Bid Security

All bids shall be accompanied by a *bid security* in the form of a bank guarantee in the amount equal to 2.5% of the sub-project budget allocation, or alternately, in the form of *cash or Bank Manager's/Bank Cashier's check* (payable to: Community and Family Services International) in the amount equal to 2.0% of the sub-project budget allocation.
