# Invitation to Bid

## I. Procuring Entity

Community and Family Services International (CFSI) is the Grant Recipient and Implementing Agency, as such, the primary procuring entity<sup>1</sup> for the World Bank-administered Bangsamoro Camps Transformation Project. This initiative, known as BCTP, aims to improve access to socio-economic services and basic infrastructure in target communities, and is fully aligned with the main objective of the Bangsamoro Normalization Trust Fund (BNTF), which is to assist in the development of the MILF camps, leading to transforming these areas into peaceful and productive communities. BCTP implementation is essential in supporting the gains of the peace process and the legitimacy of the Comprehensive Agreement on the Bangsamoro (CAB). The BCTP, under its Community Development Assistance (CDA) component, included funds for the construction of various community infrastructure sub-projects in the form of small Socio-Economic Infrastructures (SEI) and Community Facilities (CF).

# **II. Implementing Partners**

CFSI, working in close collaboration with the Bangsamoro Development Agency (BDA) and the Joint Task Force on Camps Transformation (JTFCT), now requests sealed bids/quotes from eligible and qualified bidders/firms for various Works to be implemented in the provinces of Maguindanao del Norte, Maguindanao del Sur Lanao del Sur, Lanao del Norte and North Cotabato, as stated in the table below. The construction period is One Hundred Twenty (120) calendar days.

# **III. Procurement Method**

Bidding/RFQ will be conducted through the Local Competitive Bidding (LCB) method and is open to all interested bidders/firms from the project areas or their vicinity, and other eligible bidders/firms as defined in the Bidding Documents.

Interested eligible bidders/firms can obtain further information from the Chairperson of the Joint Procurement and Evaluation Committee (JPEC) and inspect the bidding documents at the addresses given at the bottom of this announcement.

### IV. General Qualifications of Bidders/Firms

Qualifications requirements include:

- Legal registration as a business entity,
- Accreditation with the Philippine Contractors Accreditation Board (PCAB), experience in the same or similar project, and
- Clear financial capacity to undertake the Works.

#### V. Issuance Bid Documents

A complete set of Bidding Documents in English may be purchased by interested bidders from 25 March 2024 to 16 April 2024 upon submission of a written intent/application to either of the addresses below, and upon remittance of a non-refundable fund contribution in the amount of Five Thousand Philippine Pesos (P5,000.00), in the form of cash, but for bid packages with Indigenous People (IP) sub-projects, an additional amount of Two Thousand pesos (Php2,000.00) will be collected. This contribution is to cover documentation expenses related to the bidding/procurement process. Late submission of bids/quotes will be rejected, Bidders/Firms are encouraged to submit their bids/quotes as soon as possible to avoid disqualification.
