### Invitation to Bid

#### 1. Procuring Entity

Community and Family Services International (CFSI) is the beneficiary of a grant and, as such, the primary procuring entity for the Spanish Agency for International Development Cooperation (AECID)-funded Communities for Learning and Employment Project (CLEP). This initiative aims to design and test a training mechanism for access to employment and/or income for 1,800 residents, primarily females, of the six MILF camps. CLEP is designed to be in accordance with the normalization process outlined in the Comprehensive Agreement on the Bangsamoro (CAB) and informed by the Bangsamoro Organic Law, the Camps Transformation Plan, and the Camps Investment Program, all promoting inclusion, peace, and disaster risk reduction, as well as improving the situation of women, youth, persons with disabilities, indigenous peoples, and transitioning combatants. The general objective of CLEP is to promote peace and sustainable local development in the six MILF camps and their areas of influence. CLEP, under Result 2, includes funds for the construction of Community Learning Centers (CLC) in select areas.

#### 2. Implementing Partners

CFSI, working in close collaboration with the Joint Task Force on Camps Transformation (JTFACT), now requests sealed bids from eligible and qualified bidders for various works to be implemented in areas of Maguindanao del Norte, Maguindanao del Sur, Lanao del Norte, and Lanao del Sur, as listed in the table below. The construction period is Ninety (90) calendar days.

### 3. Procurement Method

Bidding will be conducted through the Local Competitive Bidding (LCB) method. It is open to all interested bidders from the project areas or their vicinity, as well as other eligible bidders, as defined in the Bidding Documents.

Interested eligible bidders can obtain further information from the Chairperson of the Procurement and Evaluation Committee (PEC) and inspect the Bidding Documents at the addresses given at the bottom of this announcement.

### 4. Bidders General Qualifications

Qualifications requirements include legal registration as a business entity, accreditation with the Philippine Contractors Accreditation Board (PCAB), experience in the same or similar project, and clear financial capacity to undertake the Works. Specific requirements are contained/specified in the Bidding Documents.

### 5. Issuance of Bid Documents

A complete set of Bidding Documents in English may be purchased by interested bidders from 06 May 2024 to 20 May 2024 upon submission of a written intent/application to either of the addresses below and upon remittance of a non-refundable fund contribution in the amount of Four Thousand (P4,000.00) Pesos in Philippine currency, in the form of cash. This contribution is to cover documentation expenses related to the bidding/procurement process. Late bids will be rejected.

## 8. Site Inspection

Site inspections for sub-projects for Camp Abubakar, Camp Badre, Camp Omar, and Camp Rajamuda will be conducted on 8 and 9 May 2024.

Site inspections for sub-projects for Camp Bilal and Camp Bushra will be conducted on 15 and 16 May 2024.

Contractors/Bidders are required to submit a duly signed certificate issued by CFSI as proof of having completed the site inspection.
